Route 17 East or West to Exit 121 West (Route 84 West) to Exit 3W (17M). Right at end of ramp, onto 17M (Dolson Ave.). Left at County Road 108. CR 108 becomes CR 78. Continue on CR 78 to Maple Hill Elementary School entrance at Egerton Ave Take a right onto Egerton Ave into the Middletown Community Campus. Turn left on Empire Dr. Then right on Ashley Ave. Turn left on Seward Ave.
